**ENERGY ASSISTANCE PROGRAM – ARREARAGE PAYMENT COMPONENT ENERGY BURDEN PERCENTAGE WAIVED**

The Low Income Home Energy Assistance and Nevada Fund for Energy Assistance State Plans provide the Division of Welfare & Supportive Services’ Administrator the authority to reduce or eliminate the energy burden for the arrearage payment component to optimize the assistance provided to eligible households based on projected caseload, available program funding, and/or circumstances that warrant an adjustment (e.g., moratoriums on utility payments etc.).

Due to the health emergency and available funding, the Energy Assistance Program will eliminate the energy burden for the arrearage payment component for Program Year 2021 and 2022.

**EFFECTIVE DATE: Retroactively to July 1, 2020**

Note: All Program Year 2021 Energy Assistance Program applications determined eligible for assistance that were denied arrearage assistance for not meeting the energy burden will be re-evaluated.
